Fees for 2018 are £40 for Full / Probationary / Trainee membership; Seniors (65+), Juniors (u25) and Associate members £30. Payment may also be made via BACs to 60 04 20 – 94652120 giving your surname as the reference.

Initial applicants for membership should also enclose 3 x passport sized photos. Alternatively, these may be sent electronically.

LERA's membership year runs from 01 Apr to 31 Mar. Please ensure your renewal form reaches the Secretary by 31 Mar. You will not be covered by the Association's insurance after this date should you fail to renew your membership and any Shooter Certification Card issued via the Association will also no longer be valid.

The Secretary is obliged to notify the Police of anyone who has not renewed their membership within one month of the expiry date. If LERA is your primary club, failure to renew membership could put you in contravention of the conditions of your FAC.

RENEWALS: On receipt of this completed form and payment of the appropriate fee you will be sent a receipt sticker to append to your membership card. Should you require an updated membership card please enclose 2 x passport photos with your renewal form and payment.

INITIAL APPLICATIONS: On receipt of your form and payment the Secretary will submit your details to Surrey Police Firearms Dept for routine checks. Once 'application may proceed' authority has been received from the Police you will be issued a membership card, be invited to join the LERA Facebook Group, and given a login to the members only area of the LERA website. All new members are required to complete a six-month probationary period and attend a minimum of three shooting meetings before converting to full membership.

TRAINEES: Applicants new to the sport of target shooting and who do not have a SCC must undergo probationary training and pass an assessment test before being allowed to shoot unsupervised. The LERA Training Officer will liaise with you to arrange this. An additional fee is charged for probationary training.
